







Wall Mount Installation Instructions

 Screw the universal flush mount wall bracket into the wall mounted back box using the appropriate screws for US or EU boxes as shown below.






2. Optional, if portrait mounting the touchscreen, remove the 4 screws on the T-10 Glass rear panel support bracket. Rotate the support bracket 90 degrees so the RJ-45 points down in the desired orientation and ensure the indicated notch in the support bracket is pointed down. Take care not to disconnect or strain the internal cables when rotating the bracket. Reattach with the same screws. The same steps can be performed to convert a portrait screen back to landscape.



3. Connect the CAT5/6 cable to the T-10 Glass touchscreen.




4. Attach the T-10 Glass touchscreen onto the universal flush mount wall bracket by first hooking the snaps on the touchscreen rear panel onto the top tabs of the wall bracket. Then press the bottom of the touchscreen enclosure to snap the bottom hooks onto the tabs of the wall bracket.



5. To remove the T-10 Glass from the universal wall mount bracket, insert a pry-tool (e.g. flat head screwdriver) between the universal wall mount bracket and the support bracket. Gently twist/rotate the tool from one side to the other to disengage the tabs on support bracket from the flanges on the wall mount bracket.







Tabletop Stand Installation Instructions

The instructions below describe how to mount the T-10 to the optional tabletop stand (purchased separately).

1 - Attach the universal flush mount wall bracket to the upper and lower table mount stand sections using the eight (8) included 6-32 x ½ screws, as shown in the image on the left.



2. Attach the four (4) included non-skid pads to the underside of either the upper or lower table mount bracket, depending on which surface will be rested upon.



- 3. Connect the CAT5/6 cable to the T-10 Glass touchscreen.
- 4. Align and gently press the T-10 unit onto the wall mount bracket by first hooking the snaps on the touchscreen rear panel onto the top tabs of the wall bracket. Then press the bottom of the touchscreen enclosure to snap the bottom hooks onto the tabs of the wall bracket. Ensure the device is seated and flush to the tabletop stand.
- 5. To remove the T-10 Glass from the universal wall mount bracket, insert a pry-tool (e.g. flat head screwdriver) between the universal wall mount bracket and the support bracket. Gently twist/rotate the tool from one side to the other to disengage the tabs on support bracket from the flanges on the wall mount bracket.



Software Installation

ComposerTM is the software that provides real-time set-up and control of the T-10 Glass touchscreen from a Windows PC environment.

Use the following procedure to install ComposerTM on your computer

- Download the Composer™ software installer from the Symetrix web site (https://www.symetrix.co).
- 2. Double-click on the downloaded file and follow the onscreen directions to install.

After installing the software, refer to the Help File for full connection and configuration information.

Network Setup

About DHCP

T-10 Glass touchscreen boots with DHCP enabled by default. This means that as soon as you connect it to a network, it will look for a DHCP server in order to obtain an IP address. If a DHCP server is present, T-10 Glass touchscreen will obtain an IP address from it. This process may take several minutes. With your PC attached to the same network, and thus getting its IP address from the same DHCP server, all will be ready to go.

If your network does not have a DHCP server, T-10 Glass touchscreen will not be able to obtain an IP address. While waiting, T-10 Glass touchscreen will default to a private IP address in the range of 169.254.x.x where x.x is the last four alphanumeric characters of T-10 Glass touchscreen's MAC address (MAC address hex value is converted to decimal for IP address). T-10 Glass touchscreen's MAC address can be found on a sticker on the bottom of the hardware.

When there is no DHCP server present to assign IP addresses to the T-10 Glass touchscreen, or your PC, you may need to configure your PC with a static IP in the range of 169.254.x.x with a Subnet Mask of 255.255.0.0 in order to communicate with T-10 Glass touchscreen in a direct connect mode. However, if your PC is using the default network settings, it should also have automatically self-assigned a similar private IP address in the range of 169.254.x.x, and if this is the case, you should be able to connect to T-10 Glass touchscreen directly.

Even if the PC's default settings have been changed, T-10 Glass touchscreen will try to establish communications by setting up appropriate routing table entries to reach devices with 169.254.x.x addresses.

Connecting to T-10 Glass from a host computer on the same LAN

The T-10 Glass and the host computer require the following 3 items:

- 1. IP Address The unique address of a node on a network.
- 2. Subnet Mask Configuration that defines which IP addresses are included in a particular subnet.
- 3. Default Gateway (optional) The IP address of a device that routes traffic from one subnet to another. (This is only needed when the PC and T-10 Glass are on different subnets).





If you are putting T-10 Glass on an existing network, a network administrator will be able to provide the above information, or it may have been provided automatically by a DHCP server. For security reasons, it is not recommended to put T-10 Glass directly on the Internet. If you do, a network administrator or your Internet Service Provider can provide the above information.

If you are on your own private network, directly or indirectly connected to T-10 Glass, you may allow the device to choose an automatic IP address or you may choose to assign it a static IP address. If you are building your own separate network with static assigned addresses, you may consider using an IP Address from one of the "Private-Use" networks noted in RFC-1918:

- 1. 172.16.0.0/12 = IP Addresses 172.16.0.1 through 172.31.254.254 and a Subnet Mask of 255.240.0.0
- 192.168.0.0/16 = IP Addresses 192.168.0.1 through 192.168.254.254 and a Subnet Mask of 255.255.0.0
- 10.0.0.0/8 = IP Addresses 10.0.0.1 through 10.254.254.254 and a Subnet Mask of 255.255.0.0

Configuring IP Parameters

Locating Hardware



Discovery of, and connection to, T-10 Glass touchscreen hardware is done with the Locate Hardware dialog found under the Hardware menu or by clicking the Locate Hardware icon in the tool bar or on a particular T-10 Glass touchscreen unit itself.

IP Configuration with Composer™

The Locate Hardware dialog will scan the network and list available units. Select the T-10 Glass touchscreen unit you wish to assign an IP address to and click the Properties button. If you wish to assign a T-10 Glass touchscreen a static IP address, select "Use the following IP address" and enter the appropriate IP address, Subnet mask and Gateway. Click OK when finished. Now, back in the Locate Hardware dialog, ensure the T-10 Glass touchscreen device is selected and click "Select Hardware Unit" to use this T-10 Glass touchscreen hardware in your Site File.

Close the Locate Hardware dialog.

Reset Switch

To be used under the supervision of technical support, it has the ability to reset the T-10 Glass touchscreen's network configuration and completely reset the unit to factory defaults. Locate the reset switch through the vents on the bottom side of the T-10 Glass rear cover.

- 1. Short press and release: Reboots the unit.
- 2. Long press and hold, release when unit reboots: Resets network configuration, returns to DHCP.
- 3. Apply power while holding, release after unit boots then reboots: Factory resets unit.
